Secure site access

- Ensure your duty of care is met by keeping visitors, staff, and contractors safe on site.
- Integrated access control in highly secure areas where HR and SMS data automatically check competencies and enforce compliance with regulations and standards.
- Check personnel at the door to make sure they are capable, qualified, and compliant with a wide range of standards and regulations.
- Monitor inductions, licenses, training, and qualifications to only allow people access to areas they are sufficiently qualified to be in.
- Cardholder movement can be tracked and controlled at doors, boom gates, vehicles – anywhere a reader is mounted.
- Deter, detect, and respond to unauthorized entry on site with our perimeter detection solutions.

Rapid evacuation and lockdown

- Account for personnel in the event of an incident, particularly important in an underground environment.
- Easily identify where people are on site, particularly in hazardous or unsafe areas, using Command Centre's Tag Boards feature.
- Partial or total site lockdown during threat or emergency situations allows only a selected group of staff (e.g. rescue or medical personnel) to enter and exit locked down zones.
- Actively monitor workers within a zone, local or remote sites and ensure blast zones have been cleared before explosives are detonated.

Employee and visitor management

- Ensure the security control room is aware of workers who are alone on remote sites.
- Monitor who remains within a high security area at the end of a working day or shift.
- Contractor management can be granted and controlled based on the time and date they are expected to be on site.
- Cardholder movement is immediately reflected in the system site-wide providing all operators with a single, real-time view.
- Automatic revocation of contractor and visitor cards prevents unauthorized access after their contract has expired.

Protect valuable assets

- Supervise access to restricted areas with intelligent alarm monitoring and advanced site map functionality.
- Use zone counting to monitor the number of people in an area on site.
- Produce comprehensive audit trails for a high level of traceability, for both internal use and regulatory audits.
- Control access to restricted areas with valuable assets such as heavy machinery and vehicles

Simplify administration

- Command Centre's integration with HR systems and automated administration systems free employees from the burden of admin work, making them more efficient.
- Powerful reporting saves time and provides an audit trail of events to document facility use and event reporting.

- Monitor and report on time-on-site, accumulated time-on-site and minimum break periods between shifts for all cardholders including visitors, employees and contractors.
